1. **MOORISH ZODIAC CONSTITUTION- Article Two (2), Para, one (1), Article Three (3) Para. One (1), Article Four (4), Para. Two (2) and Article Six (6), Para two (2).**
2. **UNITED STATES DEPARTMENT OF JUSTICE – Moorish Credentials, with Zodiac Constitution, CLASSIFIED – Truth A – 1 Foreign Relations and**

(5) – (Liberty Clause) and Amendment Nine – (Reservation of the Rights of the People).

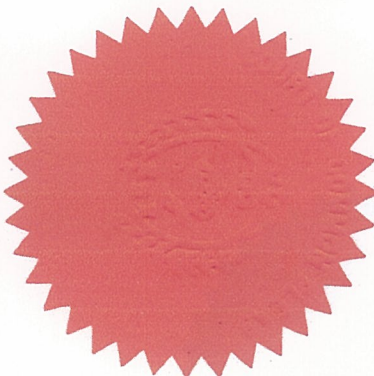
